

(Unofficial Translation) Announcement of Chulalongkorn University on the Student Dress Code B.E. 2562

As it has been deemed appropriate to amend the Announcement of Chulalongkorn University on the Student Dress Code.

By virtue of Article 12 Article 13 and Article 14 of Chulalongkorn University Regulations on Uniforms, Emblems and Dressing of Students B.E. 2562, the president and dean's meeting (number 40/2562) of November 6, 2019, approved these announcement as follows:

Article 1. This announcement is here after known as the "Announcement of Chulalongkorn University on Dressing of Students B.E. 2562"

Article 2. This announcement shall be effective from the next day of the announcement onwards.

Article 3. As used in this announcement:

"Student" means a student at Chulalongkorn University;

"Faculty" means a faculty, school, college, or common institute with equivalent status to a faculty that oversees undergraduate programs;

"Dean" means the dean of the faculty, school, or college which oversees an undergraduate program;

Article 4. Dressing in regular uniforms, royal ceremonies or state ceremonies, or ceremonial uniform shall be followed by the Chulalongkorn University Regulations on Uniforms, Emblems and Student Dress Code.

Students may wear the uniform as described above according to their birth sex or gender expressed.

In the case of Islamic female students, may dress as paragraph one but are allowed to have the following characteristics:

- (1) Shirt, the sleeves are long. The end of the sleeve is buttoned.
- (2) Skirt, the length of the skirt is at the ankle.
- (3) White headscarf without a pattern.
- (4) The university's emblem adorned on the shirt or headscarf that can be seen on the right side of the chest.

Article 5. Dressing in polite clothes as the following characteristics:

- (1) Male students consist of:
 - (A) Shirts with sleeves, do not wear T-shirts without collars and tuck the shirttail into pants, royal shirt, or inspector shirt (safari shirt), button up neatly.
 - (B) Long pants, not too tight and not exposing the torso in a manner that is inappropriate for civilians.
 - (C) Heel-covered shoes or heel-strap shoes and not slippers.
- (2) Female students consist of:
 - (A) Shirts with sleeves, not tight, do not wear T-shirts without collars or cropped tops.
 - (B) Knee-length skirts or long pants, not too tight and not exposing the torso in a manner that is inappropriate for civilians.
 - (C) Heel-covered shoes or heel-strap shoes and not slippers.

Students may wear polite clothes as described above according to their birth sex or gender expressed.

Article 6. Student dress code for various occasions is as follows:

- (1) In royal ceremonies or state ceremonies, students dress as specified in the schedule, or order of the university.
- (2) In class attendance
 - (A) Undergraduate students typically wear regular uniforms unless their instructor requires them to wear polite clothes, as instructed by the Dean. Exceptions apply to undergraduate students in programs that only accept bachelor's degree graduates, who are required to dress in polite clothes.
 - (B) Graduate students dress in polite clothes.
- (3) In the examination
 - (A) Undergraduate students wear regular uniforms. Exceptions apply to undergraduate students in programs that only accept bachelor degree graduates, who are required to dress in polite clothes.
 - (B) Graduate students dress in polite clothes.
- (4) To contact the university departments and offices
 - (A) Undergraduate students dress in regular uniforms or polite clothes.
 - (B) Graduate students dress in polite clothes.
- (5) For participation in various university activities, with no additional dress code requirements, students can dress in general attire such as sleeveless shirts, skirts, or pants that do not look precarious or expose their bodies too much in a manner that is considered inappropriate for civilians.

Article 7. The president shall act according to this announcement.

In case of any interpretation or implementation issues with this announcement, the president has the final authority to make a decision.
