Chulalongkorn University Regulations on Awarding of the Honors Degrees B.E. 2552

As it has been deemed appropriate to amend the Chulalongkorn University Regulations on Awarding of the Honors Degree.

By virtue of Article 21 (2) and Article 62 of Chulalongkorn University Act B.E. 2551, the University Council at its meeting (number 719) on December 24, 2009, approved these regulations as follows:

Article 1. These regulations are here after known as the "Chulalongkorn University Regulations on Awarding of the Honors Degree B.E. 2552".

Article 2. These regulations shall be effective from the academic year 2010 onwards.

Article 3. As used in these regulations:

"Faculty" means a division that offer education at the bachelor's level;

"Student" means a student at Chulalongkorn University.

Article 4. Students who have completed a bachelor's degree may be eligible to receive an honors degree if they meet one of the following qualifications:

- (1) The study period for a 4-year program must not exceed 4 academic years or equivalent.
- (2) The study period for a 5-year program must not exceed 5 academic years or equivalent.
- (3) The study period for a 6-year program must not exceed 6 academic years or equivalent.
- (4) The study period for a designated 3-year second degree or graduate program must not exceed 3 academic years or equivalent.

The calculation of the study period under paragraph one shall not include the semester in which a study leave has been granted, or the semester in which a study abroad program has been granted with an international student exchange scholarship or any other scholarships that directly benefit the student's undergraduate studies, subject to the approval of the Faculty Executive Committee.

Article 5. Students who are eligible for second-class honors degrees must pass the examination with the number of credits required for the course, and have received a cumulative grade point average (GPAX) of 3.25 or higher, with no course having an F or U.

Article 6. Students who are eligible for first-class honors degrees must pass the examination with the number of credits required for the course, and have received a cumulative grade point average (GPAX) of 3.60 or higher, with no course having an F or U.

Article 7. The faculty may determine the additional qualifications for students who deserve honors degrees, in addition to those specified in Article 4., Article 5. and Article 6. with the approval of the dean's meeting and announce them as a university announcement.

Article 8. The Faculty Executive Committee or the Academic Committee to which the student is affiliated may nominate the student who meets the qualifications specified in these regulations for an honors degree, which must be approved by the University Council.

Article 9. The president shall act according to this announcement.

Temporary Provisions

Article 10. Granting of honors degrees to students who entered the university prior to the effective date of this regulation shall be in accordance with the criteria set forth in the University Regulations on Awarding Honors Degrees, which are in force on the date the student enters the University.
